

## FUNDING REQUEST PROCEDURE

Community Opportunities for People with Developmental Disabilities is established as a political subdivision and operates under the Revised Missouri Statutes 205.968-205.972. Under the authority of these statutes, Community Opportunities may contract for services for people with developmental disabilities. Community Opportunities will contract with non-profit organizations that assist in providing services and supports that help to achieve the organizations mission. The mission of Community Opportunities is to conduct programs and/or provide opportunities that secure services and promote the general welfare of citizens with intellectual and/or developmental disabilities from the Lincoln County area in keeping with the following philosophy:

Community Opportunities and the employees (referred to as "We") are committed to the philosophy that citizens with intellectual and/or developmental disabilities have the following rights:

- ◆ To achieve as high a quality of life as possible;
- ◆ To grow and learn in the least restrictive environment as allowed by their skill level;
- ◆ To pursue to their fullest extent, personal lifestyles and goals;
- ◆ To participate as fully as possible in all decisions about themselves, with the assistance of their families and/or guardians, as well as the staff involved.

Community Opportunities is most interested in funding services which provide for integrated community inclusion.

**To apply for funding for the fiscal year, July 1, 2024 through June 30, 2025 a written proposal must be submitted by March 15, 2024 (5 copies please).** All funds must be expended in compliance with procedures for spending public funds. The written proposal must include the following information (**Do not submit additional materials.
